Overview of Title 1

The Title I Program...

- is the largest federal assistance program for schools.
- provides support to students who are most at risk of not meeting the state's academic standards.
- bases funds on the number of students receiving free or reduced price lunch.
- supports parents by offering workshops and training opportunities to increase their involvement in their children's education.

School Wide Program

- While an emphasis is placed on students at risk of not meeting academic standards, all students at the school benefit from Title I funds.
- Academic resources, equipment, professional development, and teachers are funded through Title I to benefit all students and parents.

- High Quality Curriculum
- Academic Assistance to the Most At-Risk Student
- Parent Involvement and Input
- Annual Evaluation of Title I Program(s)
- Timely Communication to Parents


